## VALUE:

The scholarship check will be made out to the recipient after providing proof of satisfactory performance of being a full time student (one semester or term) and proof of registration for the following semester or term.

## JUDGES:

The scholarship winners will be selected by the Co Presidents, Joan Lawson and Randy Pieper.

## ANNOUNCEMENT:

Selection will be made at the Senior Graduation Awards Night.

## INSTRUCTIONS:

1. The application form should be **typewritten or written legibly by ink.**
2. The application must be completed in full with a **current certified school transcript.**
3. Two letters of personal reference are to accompany this application. **One to be from a current teacher and the other from a community member** (scout leader, pastor, business leader, etc.)
4. The student must have attended one of the qualifying school districts for a minimum of one school year and must plan to graduate from the same school. A qualifying school is one that banks with Farmers State Bank of Calhan/Falcon/Ellicott.
5. The student or the student's parents or guardians must have been a customer of Farmers State Bank of Calhan/Falcon/Ellicott for a **minimum of 6 months and must still be bank customers.**
6. A **letter of acceptance** from an accredited educational institution (college, Jr. college, trade, vocational school) in state, or out-of-state, must accompany this application.
7. The applicant must have at least a **22 ACT or 1000 SAT score and a grade point average of 3.0.**
8. The application for the educational grant is due in the counselor's office by **April 16<sup>th</sup>.**
9. Students of employees of Farmers State Bank of Calhan/Falcon/Ellicott are not eligible.
10. **Attach a one-page letter** to Farmers State Bank of Calhan/Falcon/Ellicott commenting briefly on your educational and vocational plans and goals, and give other information that would be helpful in assessing your merit for this scholarship.
11. Please fill out the photo release and attach a photo. The photo will be used when recognizing the winners on Facebook.
